# Report on Recent Research in Theoretical Philosophy at Stockholm University, the Department of Philosophy

Revised December 2014

The department of philosophy is traditionally divided into practical philosophy and theoretical philosophy. Philosophy has been assigned the status of a leading area at Stockholm University; this applies to both areas of the subject. What follows here is a description of research pursued in theoretical philosophy.

## About the department

Philosophy is one of the 'profile' areas selected by Stockholm University, i.e. selected as an area where the department has a leading position in the country and is strong internationally. The department has a very wide competence across the entire philosophical field, and a high international profile, with frequent publications in leading journals, guest lectures and conference participation abroad by department members, as well as regular guest lectures and conferences and workshops at home.

In a recent international report of the quality of research at the department the following overall assessment is given: "we find the quality of research and the level of activity of the Philosophy Department at Stockholm University outstanding, especially in terms of research output, conferences, colloquia, visits, visitors, and research collaboration [...]. It is quite clear from the list of publications and the other material presented to us that the Philosophy Department in Stockholm has active research teams in several major areas of philosophy, whose work is internationally prominent (not only recognized), and in fact excellent by any national or international standards" (Report on the quality of research at the Philosophy Department, Stockholm University, November 2011).

The department has since continued to produce excellent research and to attract internationally prominent researchers, like professor Anandi Hattiangadi, who left Oxford in 2012 in order to join the department as a Pro Futura Scientia Fellow, and professor Valentin Goranko, who was recently appointed professor of logic.

### Main research interests

Philosophy of language, philosophy of logic and mathematics

Philosophy of language, philosophy of logic and mathematics

The department is particularly strong in this area. The central works in logic by Dag Prawitz and Per Martin-Löf are modern classics. Prawitz is presently writing a book together with Peter Schroeder-Heister (Tübingen) on general proof theory. Valentin Goranko is one of the leading figures in the area of modal logic, and is currently (apart from doing theoretical work) exploring applications of logic to agency and multi-agent systems (logics for qualitative and quantitative strategic reasoning; logics for visual-epistemic reasoning; temporal-epistemic logics; logics of ignorance; tableaux-based methods for constructive satisfiability testing and model synthesis in multi-agent logics; secure aggregation of distributed information). Goranko's research

topics also include artificial intelligence, computer science, game theory, and interval temporal logics. Pagin and Westerståhl, partly in collaboration, are doing work on compositional semantics that is at the front line of the field (several handbook articles). Westerståhl is internationally renowned for his work on generalized quantifiers, and was appointed leading researcher by the *Swedish Research Council* (2005-2010). His book with Stanley Peters, *Quantifiers in Language and Logic*, OUP, 2006, 2008) is a standard reference in the field. Presently he is doing research on generalized quantifiers in language and logic, in particular possessive quantification (joint work with Stanley Peters), logical consequence and logical constants (joint work with Denis Bonnay), and "Saussurean compositionality" for grammars generating syntax-semantics pairs (Saussurean signs).

Pagin, and Glüer and Pagin, also have several contributions to the area of formal semantics. In particular, Glüer and Pagin have developed a framework for semantics—*switcher semantics*—that has been applied in possible world semantics, and that is currently gaining attention. They are currently preparing a book manuscript on this topic, under contract with Oxford University Press. In addition, Pagin works on semantic complexity, the semantics-pragmatics interface, assertion (with an entry in *Stanford Encyclopedia*), communication, pragmatic enrichments, semantics for non-extensional contexts, empty singular terms, and vagueness.

Hattiangadi, Glüer, Pagin, Prawitz, Häggqvist, Wikforss and Åkerman all work on various aspects of general meaning theory. Prawitz is currently working on a project within the theory of meaning concerning what gives an inference or a deduction its epistemic force. Hattiangadi, Glüer and Wikforss all work on the question of the normativity of linguistic meaning and mental content, and have several prestigious publications in the area, including articles in *Mind* and *Stanford* Encyclopedia (Wikforss and Glüer), and a monograph entitled Oughts and Thoughts: Rule Following and the Normativity of Content (Hattiangadi) published by Oxford University Press (2007). Glüer, Pagin, Häggqvist and Wikforss all work on the semantics of natural kind terms. Wikforss has published several articles on questions of internalism and externalism in semantics, including a survey article in *Philosophy Compass*. Häggqvist works on teleosemantics, with a recent survey article in *Philosophy Compass*. Glüer is an international authority on the philosophy of Davidson, with contributions to several encyclopedias and handbooks, including a monograph published by Oxford University Press (2012). Åkerman recently finalised a project entitled 'Mental States and Utterance Content' financed by the Swedish Research Council. He has several publications (recent and forthcoming) on vagueness, context sensitivity and indexicals, in journals like Australasian Journal of Philosophy, Mind & Language, dialectica, Philosophical Quarterly, and *Philosophy Compass*, and in a new anthology on the Sorites paradox to be published by Springer.

Hattiangadi is currently working on a new monograph provisionally entitled *The Fundamentality of Intentionality*, in which she will defend the view that the intentional and semantic properties of mental and linguistic representations – their meaning, content, truth or falsity – are fundamental and cannot be reductively explained in non-semantic terms.

Malmnäs does work on probability theory, the foundations of decision theory and the analysis of complex decision making. He is in charge of a program on decision, risk- and policy analysis.

#### Epistemology, philosophy of mind and action

Häggqvist works on modal epistemology, and is internationally known for his work on thought

experiments. Glüer works on perception, where her position is gaining widespread attention, in particular because of her recent article in *Mind & Language*. Glüer and Wikforss also work on issues concerning the nature of belief and epistemic rationality. Wikforss is currently working on the epistemology of self-knowledge, and she has a contract with Oxford University Press for a book on knowledge of content and belief. Glüer and Wikforss has recently received funding from VR (the Swedish Research Council) for a five-year project entitled "The Nature of Belief" (this is the first five year project in philosophy ever financed by VR).

Janvid has several international publications in epistemology, with a special focus on a priori justification, defeasibility, scepticism, epistemic value and understanding. He is currently working on an externalist account of defeaters.

Carlshamre is currently involved in a project supported by the *Bank of Sweden Tercentenary Foundation*, where he works on the semantics and epistemology of narratives.

Several people work on the philosophy of action. Glüer works on Davidson's action theory. Grönroos, Murdoch and Quarfood all work (or have worked) within the project 'Understanding Agency', funded by the *Bank of Sweden Tercentenary Foundation*, which deals with questions concerning agency from a historical perspective. Murdoch is a member of the governing board of this research program.

#### Philosophy of science, metaphysics

Needham is internationally renowned for his work in philosophy of chemistry (with a collaborative recent entry in *Stanford Encyclopedia*). He has published both on the history of philosophy of science (including work on the Aristotelian and Stoic views about the nature of chemical substances, and work on Duhem's philosophy of science), and on mereology and chemical substances (with a recent publication in *Nous* criticizing Kripkean micro-essentialism). He is presently working on issues concerned with the "same substance" relation underlying distinctions of chemical kinds, and the nature of chemical bonding and the bearing of philosophical doctrines of realism associated with ideas of preservation of reference through theory change on the notion of molecules. He also works on the general notion of reduction, and on metaphysical issues concerning space and time.

Dugald Murdoch's book on Niels Bohr's philosophy of Physics for Cambridge University Press is a leading text in its field, and has been highly praised in numerous reviews. Carlshamre works on philosophy of the humanities, and is currently writing a textbook on the topic. Häggqvist works on the nature of natural kinds, partly in collaboration with Wikforss.

#### History of philosophy, aesthetics

Dugald Murdoch has an international reputation in the history of philosophy, being joint translator of the philosophical works of Descartes for Cambridge University Press, and author of prestigious articles on Descartes and Hume in top-ranked journals such as *The Philosophical Review*, *the Journal of Philosophy*, and *the Philosophical Quarterly*, as well as contributions to leading encyclopaedias and compendia.

The department has several researchers working on ancient philosophy. Gösta Grönroos has published articles in the top-tier journals in the field such as *Oxford Studies in Ancient Philosophy*, *Journal of the History of Philosophy* and *Phronesis*. Grönroos has recently published on Plato's notion of belief, and on the role of reason in motivation in Aristotle, and he is currently working on

the role of pleasure in virtuous activity in Aristotle and on the notion of voluntariness in Plato and Aristotle.

Quarfood's research is concerned with the interpretation of Kant's philosophy, especially with regard to teleology, the antinomies and the role of Aristotelian logic in Kant's thought.

Carlshamre writes on Hegel, and is currently working on a commentary on Hegel's 'Phenomenology of Spirit'. Svensson has worked on the philosophy of Wittgenstein, especially on 'On Certainty'. Wikforss and Glüer have also written on Wittgenstein, in particular on Wittgenstein's ideas about meaning and rule-following. Foultier works on the philosophy of Merleau-Ponty and has translated Simone de Beauvoir's philosophical essays into Swedish.

Pettersson has written about the phenomenology of photography; about the role of causality in photography; and about an often-neglected aspect of picture perception, namely how we apprehend occluded portions of depicted objects, and objects that lie outside the picture frame. He is presently working on issues concerned with pictures and our apprehension of them, in particular our apprehension of less canonical pictorial contents, including absences, empty space and psychological properties.

Carlshamre also works on aesthetics and is one the board of an interdisciplinary graduate school in aesthetics. Two of the graduate students belong to this school (Brück and Forsberg) doing work in philosophy of art, literature and music.

### Current and recently finalised projects

In 2009, after Philosophy was selected as a profile area at Stockholm University, the department was given some extra funding. One result of this was that the department started a new center, CLLAM, the Centre for Logic Language and Mind. The purpose of CLLAM is to further research and international cooperation in the areas of Logic, Philosophy of Language, and Philosophy of Mind. One aim is that the Centre itself will be partner in international networks and participate in network projects within these research areas. The Centre will also organize conferences, support network activities for associated researchers and PhD students, and, if it has the resources, finance research in these areas. The Centre is a partner of PLM, Philosophy of Language and Mind, a philosophical network of centres, departments and institutes in Paris, Barcelona, London, St Andrews, Aberdeen, Budapest, Oslo and Amsterdam. Every two years PLM will organize a conference in the philosophy of language and philosophy mind area (where the first one is organized by Stockholm University, September 2011). Following an evaluation by the division board of the faculty of Humanities, CLLAM's status as a recognized centre at Stockholm University was renewed in 2014.

In 2011 a group of researchers at the Centre (Häggqvist, Pagin and Wikforss) received an ESF grant for an international Collaborative Research Project (CRP), 'Communication in Context', within the Eurocores program Eurounderstanding. The CRP has research groups in Amsterdam, Lisbon, London, Osnabrück, Tartu, Trondheim, and Tuebingen. Wikforss is project leader for the whole CRP, and in 2012 Glüer and Åkerman were added to the project. Recently the final conference for the whole Eurounderstanding program was held in Lisbon, and in the final evaluation the project was given a very strong evaluation.

The Centre also participates in PETAF, (Perspectival Thoughts and Facts), a network project in the ITN program, under the Marie Curie program, within EU Framework 7, led by Sven

Rosenkranz, University of Barcelona. The project funds graduate students (at Stockholm, Ivan Kasa) and organizes regular workshops and conferences. Pagin, Glüer, Häggqvist, Westerståhl and Wikforss participate in the project and Pagin is a member of the supervisory board.
